#### 2. INTERESTS THAT ARE PROVIDED TO THE LICENSEE

- 2.1. The Licensor grants the Licensee the right to use the Work in the following ways:
- to use the Work by publishing it in the collection of articles "Oriental Studies" (hereinafter Edition) in its original language;
- to use the Work by publishing it on the official websites of Edition;
- to redesign, adapt or modify in any other way the Work according to the agreement with the Licensor;
- to place the Work entirely or partially on the Internet resources of the scientific libraries which represent Edition.
- 2.2. In case if Licensee will intend to use the Work in a manner not specified in clause 2.1 of this Agreement, in particular, to publish the Work in other editions (excluding "Oriental Studies"), additional agreement should be signed between the Licensor and the Licensee.

#### 3. TERRITORY

The Licensor grants to the Licensee the right to use the Work in the ways indicated in clauses 2.1.1-2.1.4 of this Agreement, on the territory of Ukraine, as well as the right to disseminate the Work in Edition in both printed and electronic forms on the territory of Ukraine and abroad through subscription, sale and free transfer of Edition.

#### 4. PERIOD OF THE PROVIDED RIGHTS

- 4.1. This Agreement enters into force after the Licensee has accepted the Work for the publication. The contract is valid from the date of its signing and is concluded for a period of 10 years.
- 4.2. Upon expiration of the term of this Agreement in case if the written applications for its termination has not been submitted by the Licensor and / or the Licensee in proper way, the term

of this Agreement is considered automatically extended for the next 10 years.

#### 5. WARNINGS

The Licensor declares:

- that he/she is the author (co-author) of the Work;
- the Licensor guarantees that the Work is original and is not a copy of any other work, has not been previously published, and that the rights to publish it are not conveyed to anybody and that he / she is authorized by co-authors to make such a transfer;
- the Licensor guarantees that the usage of his/her copyrights does not result in any copyright infringement of any individuals or organizations and will not lead to disclosure of confidential information;
- the Licensor guarantees that, when creating the Work, the Licensor has not violated the intellectual property rights of other individuals. If the Work contains the materials of other persons, except for cases of quoting in amounts justified by the scholarly, informational or critical nature of the Work, the usage of such materials is carried out by the Licensor in compliance with the copyright norms;
- the Licensor agrees (in accordance with the Law of Ukraine "On Protection of Personal Data") with the disclosure of information about his/her personal data (information about the authors) in order to ensure the implementation of relations in the field of science.
